THE CORPORATION OF THE TOWN OF WHITCHURCH-STOUFFVILLE

BY-LAW NUMBER 2025-030-RE

BEING A BY-LAW to amend Administrative Monetary Penalty System By-law 2024-039-RE.

WHEREAS Section 434.1 of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended (the "*Municipal Act*") authorizes the Town to require a Person, subject to such conditions as the municipality considers appropriate, to pay an Administrative Penalty if the municipality is satisfied that the Person has failed to comply with a by-law of the municipality passed under the *Municipal Act*;

WHEREAS on April 17, 2024, Council enacted By-law 2024-039-RE being a by-law to establish an Administrative Monetary Penalty System for violations of designated by-laws within the Town of Whitchurch-Stouffville; and

WHEREAS Council deems it appropriate to amend the Administrative Monetary Penalty System By-law 2024-039-RE.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF WHITCHURCH-STOUFFVILLE ENACTS AS FOLLOWS:

1. By-law 2024-039-RE is hereby amended by deleting section 14.4 and replacing it with the following new section 14.4:

14.4 Where an Administrative Penalty and any applicable Administrative Fees are not paid within 15 days after the date that it becomes due and payable, the Town:

- a) may, for any Contravention respecting the parking, standing or stopping of vehicles, notify the Ontario Ministry of Transportation or the Ministry of the Attorney General (the "Ministry") of the default after sixty (60) days, at which time the Ministry shall not validate the permit of the Person named in the notice of default nor issue a new permit to the Person until the Administrative Penalty and any applicable Administrative Fees for contraventions are paid to the Town; and/or
- b) shall deem the outstanding amount for any Contravention to be unpaid taxes and shall add the amount to the tax roll for any property for which all of the owners are responsible for paying the Administrative Penalty, and collect it in the same manner as municipal taxes.
- 2. That the tables listed in Schedule 'A' of this By-law be added to Schedule 'A' of the Administrative Monetary Penalty System By-law 2024-039-RE; and
- 3. That the remainder of Schedule 'A' of the Administrative Monetary Penalty System By-law 2024-039-RE remain unchanged; and
- 4. That this By-law shall come into force and effect on the date of its passing.
